**Anti Doping for Athletes**

I, as a member of the South African National Equestrian Federation/ERASA/South African Equestrian Federation and/or a participant in a National or FEI authorized event, hereby acknowledge and agree as follows:

1. I have received (These are available on the SANEF and FEI Website and can also be bought from SANEF) and had an opportunity to review the FEI Anti-Doping Rules.
2. I consent and agree to comply with and be bound by all of the provisions of the FEI Anti-Doping Rules, including but not limited to all amendments to the Anti-Doping Rules and all International Standards incorporated in the Anti Doping Rules.
3. I acknowledge and agree that National Federations and the FEI have jurisdiction to impose sanctions as provided in the FEI Anti-Doping Rules.
4. I also acknowledge and agree that any dispute arising out of a decision made pursuant to the FEI Anti-Doping Rules, after exhaustion of the process expressly provided for in the FEI Anti-Doping Rules, may be appealed exclusively as provided in Article 13 of the FEI Anti-Doping Rules to an appellate body for final and including arbitration, which in the case of International-level Athletes is the court of Arbitration for Sport.
5. I acknowledge and agree that the decision of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
